

# FORMULA STUDENT PORTUGAL

## REGISTRATION TERMS & CONDITIONS

### 1. Competition and Organisers

- 1.1. FSPT Lda., a limited company by quotas, incorporated under the laws of Portugal, with the registry number (NIPC) 517305712 and registered office at Rua Elias Garcia, n.º 325, 7 Dto, 2700-323 Amadora, Portugal (“**Formula Student Portugal**”) is the competition national organiser.
- 1.2. The 2<sup>nd</sup> Edition (2024) of formula student engineering competition in Portugal, organised by Formula Student Portugal (the “**Competition**”), aims at developing the Formula Student national and international community and will allow 4 different categories to compete:
  - (i) Internal Combustion Vehicles (“**CV**”).
  - (ii) Electric Vehicles (“**EV**”).
  - (iii) Driverless Vehicles (“**DV**”).
  - (iv) Class 2.
- 1.3. The Competition time zone is GMT and date/time format is “DD-MM-YYYY hh:mm”.

### 2. Competition schedule and website

- 2.1. The Competition shall take place in Parque de Desportos Motorizados, Castelo Branco, located at EN 233 Km 105 - Lanço Grande, 6000-067 Castelo Branco, from 03-09-2024 to 07-09-2024.
- 2.2. The official Competition website is <https://www.formulastudent.pt/> (the “**Website**”) and all announcements and any changes to the Competition (including venue, if applicable) shall be timely available on the Website.
- 2.3. Exclusively for registration purposes and in partnership with Formula Student Switzerland, the website <https://formulastudent.ch/> (the “**FSCH Website**”) will also be used.

### 3. Application and registration process

- 3.1. The application process starts with the registration and completion of a quiz on the FSCH Website (<https://fsswitzerland.ch/>) (the “**Quiz**”). The Quiz will be available from 26/01/2024 9:00 AM (CET) and should be completed by each Team willing to participate in the Competition (“**Applicant Team**”). Applications submitted without completing the Quiz will not be considered.
- 3.2. The Competition will accept a maximum of 40 teams. The Applicant Teams will be selected according to the number of correct answers. The quiz time (starting at 9:00 AM (CET)) will only be considered as a tie-breaker. There will be two different types of slots according to the Class.
  - 3.2.1. For Class 1, there will be a maximum of 30 slots available of which:
    - a) 5 slots will be reserved for Portuguese teams.
    - b) 3 slots will be reserved for the FSPT TOP 3 EV 2023.
    - c) 3 slots will be reserved for the FSPT TOP 3 CV 2023.
    - d) 3 slots will be reserved for the FSPT TOP 3 DV Cup 2023.
    - e) 1 slot will be reserved for the Winner of Class 2 2023.
  - 3.2.2. For Class 2, a maximum of 10 slots will be available of which:
    - a) 5 slots will be reserved for Portuguese teams.
- 3.3. To ensure competition on Class 1, out of the total 30 slots available, 3 slots shall be allocated to EV and 3 slots shall be allocated to CV.
- 3.4. The registration results will be published on the Website on 29-01-2024 at 13:00 CET, and the selected Teams will be contacted by Formula Student Portugal team to conclude the registration process. Teams that have not been selected at this stage will be placed on a waiting list and can be contacted to participate if any slots for the Competition become available in the future.

#### 4. Registration Fees

- 4.1. **Class 1** teams (identified in 3.2.1) shall pay a **registration fee of 1.700€** (one thousand, seven-hundred euros) and for **Class 2** teams (identified in 3.2.2) a **registration fee of 750€** (seven-hundred and fifty euros) (the "**Registration Fees**"). Registration Fees may be subject to additional VAT, if applicable.
- 4.2. Registration Fees shall be paid by means of bank transfer to the bank account identified below:

- 4.3. Registration Fees shall be paid to Formula Student Portugal and received within 3 days of the Team receiving the invoice, for such Team participation to be confirmed. If Registration Fees are not received within such period of time, the Team will be notified and de-registered, and the slot will be allocated to the next team on the waiting list.
- 4.4. The Applicant Team shall provide Formula Student Portugal with all necessary details for the issuance of the invoice upon registration.
- 4.5. If a registered Team decides to withdraw the Competition before 01-05-2024, such Team will be entitled to a refund of 50% of the Registration Fees. If a Team withdraws from the Competition as from 02-05-2024, no Registration Fees will be refunded.

#### 5. Applicable Rules

- 5.1. The three categories mentioned in paragraph 1.2 above, will be evaluated separately and according to the following rules (all available on the Website):
- a) CV, EV and DV will be subject to the Formula Student Rules 2024 (the "FS Rules 2024").
  - b) Class 2 will be subject to the Class 2 Rules.
- 5.2. The Organiser shall publish the Formula Student Portugal Handbook on the Website and in case of conflict or divergence between this Handbook, the FS Rules 2024 and the Class 2 Rules, the first shall prevail.

#### 6. Miscellaneous

- 6.1. The Teams shall:
- a) Comply with the Competition rules and regulations, including the rules identified in clause 5 above and these Registration Terms & Conditions, in its entirety.
  - b) Check and comply with all the conditions and requirements, as well as support all costs, including taxes and custom fees, connected with the participation of all team members in the Competition and vehicle(s) shipment, freight, and importation.
- 6.2. Formula Student Portugal reserves the right to modify, extend or cancel the Competition if required by circumstances beyond its control and shall not be made responsible or liable by any consequence arising therefrom. Any changes will be communicated to the Teams through the appropriate channels and Website.
